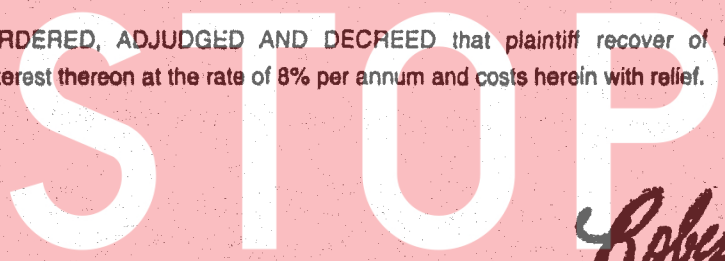

DEFAULT JUDGMENT

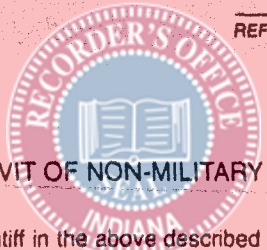
