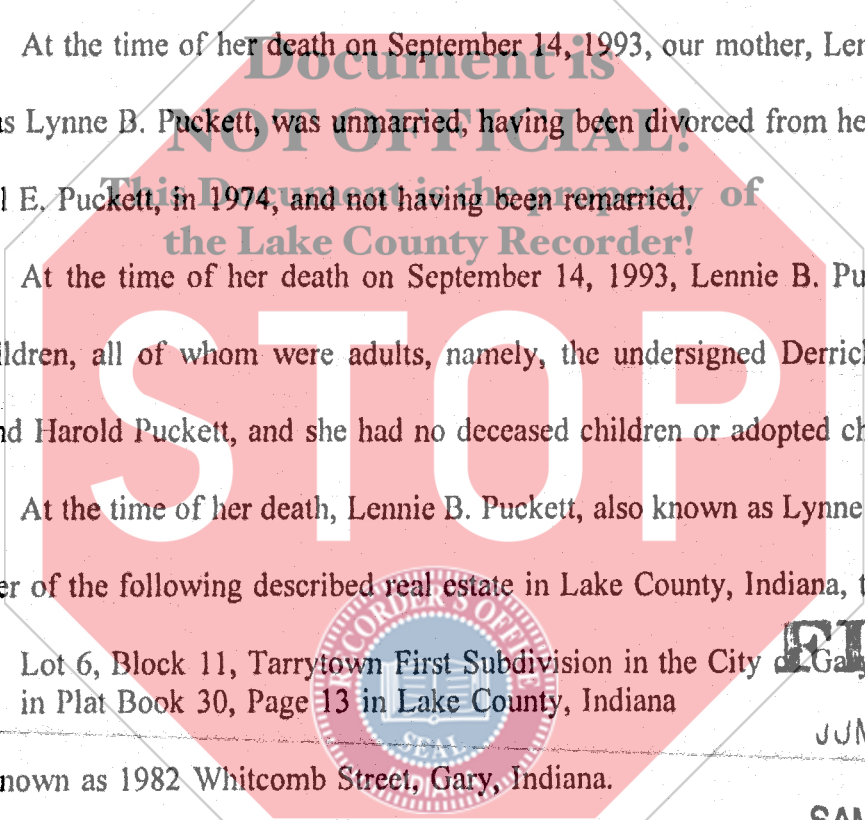
We, Derrick Puckett, Earl Puckett, II and Harold Puckett, having been first duly sworn upon our oaths state as follows:

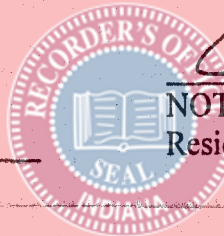

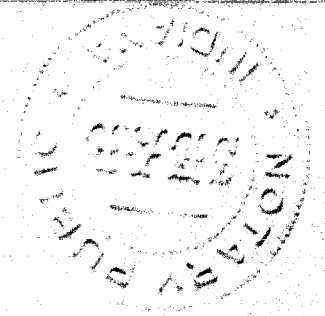
