

ASSIGNMENT OF MORTGAGE

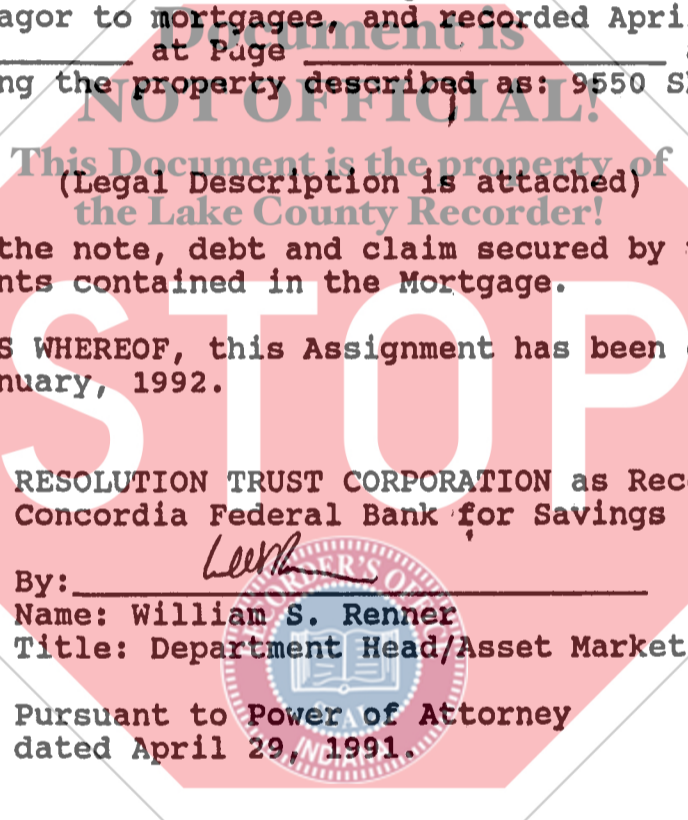

On February 16, 1989, the FHLBB, appointed the RTC as Conservator of Concordia Federal Bank for Savings transferred the subject mortgage to Concordia Federal Bank for Savings.
