THIS INDENTURE WITNESSETH, that Mark LaMere, of Lake County, Indiana, RELEASES AND QUIT-CLAIMS to Daniel M. LaMere, of Lake County, Indiana, for and in consideration of Ten Dollars and other good and valuable consideration, the receipt of which is hereby acknowledged, the following Real Estate in Lake County, Indiana, to-wit:

Part of Lots 1 and 2, in Hermit's Lake, as shown in Plat Book 30 page 92 in the Office of the Recorder of Lake County, Indiana, beginning at a point on the South line of Lot 2 at a point 115 feet West of the Southeast corner of said Lot 2; thence North on a line making an angle of 89 degrees 24 minutes with the South line of said Lot 2 (measured West to North) to a point which is 32.8 feet South of the North line of said Lot 2 measured at right angles to the northerly line of said Lot 2; thence Westerly and parallel to said Northerly line of Lot 2 to an Iron Pipe on the shore line of Hermit's Lake (being the West line of Lot 2); thence Southerly along the West line of Lot 2 (being also the shore of Hermit's Lake) to the Northeasterly corner of Lot 1 (being the Northerly corner common to Lots 1 and 2); thence Southeasterly on a line which is parallel with the Northerly line of Lot 2 to a point which is the intersection with a line parallel with the West line of Lot 1 and 200 feet East therefrom; thence South on a line parallel with the West line of Lot 1 to a point in the South line of Lot 1; thence East along the South line of Lots 1 and 2 a distance of 100 feet more or less to the place of beginning.
