Lot 27 in Ranburn Woods Section "B", as shown in Plat Book 25, page 29, Lake County, Indiana.

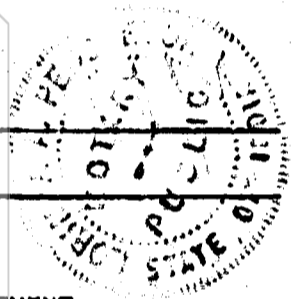
