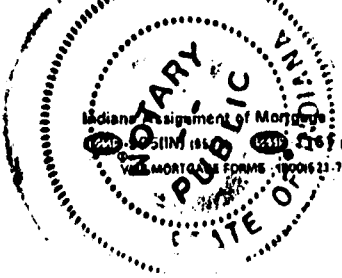

A part of the half acre parcel of land described as the East 110.83 feet of the West 2610.83 feet of that part of the North Half of the North Half of the Northwest Quarter of Section 17, Township 35 North, Range 9 West lying Southerly of the centerline of a public highway known as original or Old Lincoln Highway in the Town of Schererville, Lake County, Indiana, and more particularly described as commencing at a point in the centerline of Old Lincoln Highway which is the most Northeasterly point of said half acre parcel and marked by a railroad spike; thence South on the East line of the West 2610.83 feet of the North Half of the North Half of the Northwest Quarter of said Section 17 for a distance of 66.7 feet; thence West at right angles to said East line of the West 2610.83 feet for a distance of 76.70 feet to a North-South projected line of the 4-front door entrances; thence South on the North-South front door projection line for a distance of 36.5 feet to the West centerline projection of a party wall; thence East on the centerline projection and the centerline of said party wall 76.70 feet to the East line of the West 2610.83 feet of said North Half of the North Half of the Northwest Quarter of said Section 17; thence North on said East line for a distance of 36.5 feet to the point of beginning and containing 2800 square feet.
