TERMINATION OF EASEMENT

THIS INDENTURE OF MUTUAL TERMINATION OF EASEMENT made by and between PACKAGING CORPORATION OF AMERICA ("Easement Grantee") and WAYNE J. GOVERT ("Owner"),

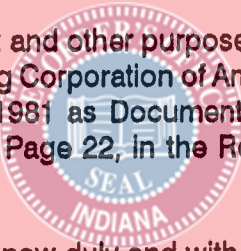
WITNESSETH

FOR and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration, receipt of which is hereby acknowledged, the above named "Easement Grantee" and "Owner" do by these presents mutually terminate the certain easement for sidetrack of railroad contained in a grant from Joliet and Northern Railroad Company to Packaging Corporation of America dated October 27, 1981 and recorded March 10, 1982 as Document Number #661764 affecting the following described real estate, to-wit:

*PT of Key 26-2-76*

Affects a 20 foot wide strip of land (for location of easement see Plat Book 54, Page 22), being part of the Northwest 1/4 of the Northwest 1/4 of Section 2, Township 35 North, Range 9 West of the 2nd Principal Meridian designated Parcel Two on the aforesaid plan of survey prepared by Torrenga Engineering, Inc., and lying 10 feet on either side of a centerline more particularly described according to said plan, as follows: Commencing at the Southeast corner of the Northwest 1/4 of the Northwest 1/4 of said Section 2; thence North along the East line of the Northwest 1/4 of the Northwest 1/4 of said Section 2, a distance of 713.52 feet to the point of beginning of said easement centerline; thence Northwesterly on a curve concave to the Northeast and having a radius of 383.065 feet, the tangent of which makes an angle of 113 degrees 41 minutes 18 seconds measured clockwise from the last described line, a distance of 79.67 feet to the point of termination of said easement centerline (said point of termination also lying on the Northerly line of the Joliet and Northern Indiana Railroad Company Property).

Also, easement for spur track and other purposes contained in a grant from L. B. Foster Company to Packaging Corporation of America dated September 14, 1981 and recorded December 9, 1981 as Document No. #653157. (For location of easement see Plat Book 54, Page 22, in the Recorder's Office of Lake County, Indiana.)
