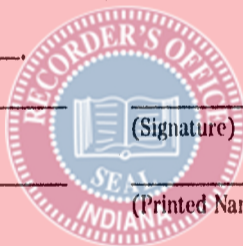

ADDENDUM TO QUIT-CLAIM DEED ATTACHED

PARCEL 1: The West 250.0 feet of the following described parcel: Part of the Northwest Quarter of the Northeast Quarter (NW 1/4, NE 1/4) of Section 24, Township 35 North, Range 9 West of the Second Principal Meridian in the Town of Schererville, Lake County, Indiana, being more particularly described as beginning at a point on the West line of said NW 1/4, NE 1/4 which is 695.0 feet South of the North line thereof; thence South, along the West line thereof, 129.46 feet, more or less, to the Northwest corner of a parcel of land conveyed to Glen W. and Elyce P. Quillin by Warranty Deed dated January 7, 1953 and recorded February 9, 1953, in Deed Record Book 931, Page 480, in the Office of the Recorder of Lake County, Indiana; thence Easterly, along the North line of said Quillin parcel, 435.6 feet; thence North, 129.46 feet, more or less, to a point on a line which is 695.0 feet South of the North line of the aforesaid NW 1/4, NE 1/4, thence West, along said line, 435.6 feet to the point of beginning, excepting therefrom the following described parcel:

Part of the Northwest Quarter of the Northeast Quarter of Section 24, Township 35 North, Range 9 West of the Second Principal Meridian more particularly described as beginning at a point which is 698 feet South and 100 feet East of the Northwest corner of said Northwest Quarter of the Northeast Quarter; thence North 3 feet; thence East 100 feet; thence South 3 feet; thence West 100 feet to the place of beginning.

PARCEL 2A: Part of the Northwest Quarter of the Northeast Quarter (NW 1/4, NE 1/4) of Section 24, Township 35 North, Range 9 West of the Second Principal Meridian in the Town of Schererville, Lake County, Indiana, being more particularly described as follows: Beginning at a point on the West line of said tract which is 695.0 feet South of the North line thereof thence South, along the West line thereof, 129.46 feet, more or less, to the Northwest corner of a parcel of land conveyed to Glen W. and Elyce P. Quillin by Warranty Deed dated January 7, 1953, and recorded February 9, 1953, in Deed Record Book 931, Page 480, in the Office of the Recorder of Lake County, Indiana; thence Easterly along the North line of said Quillin parcel, 435.6 feet; thence North, 129.46 feet, more or less, to a point on a line which is 695.0 feet South of the North line of the aforesaid NW 1/4, NE 1/4; thence West, along said line, 435.6 feet to the point of beginning, except the West 250.0 feet thereof.

PARCEL 2B: Part of a 5-foot wide Outlot in C. GORLEY'S ROLLING HILL ESTATES, as per plat thereof recorded in Plat Book 35, Page 22, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Commencing at a point on the West line of the Northeast Quarter of Section 24, Township 35 North, Range 9 West of the Second Principal Meridian which is 615.0 feet South of the Northwest corner of said Northeast Quarter; thence East, parallel to the North line of said Northeast Quarter, a distance of 435.6 feet; thence South, parallel with the West line of said Northeast Quarter 80.0 feet to the true point of beginning hereof; thence continuing South, 129.46 feet, more or less, to a point on a line 500 feet North of the South line of the Northwest Quarter of said Northeast Quarter of Section 24; thence East, 5 feet to a point on the West line of Hanley Place; thence North, along said West line, 129.46 feet, more or less, to a point 5 feet East of the point of beginning; thence West, 5 feet to the Point of beginning.
