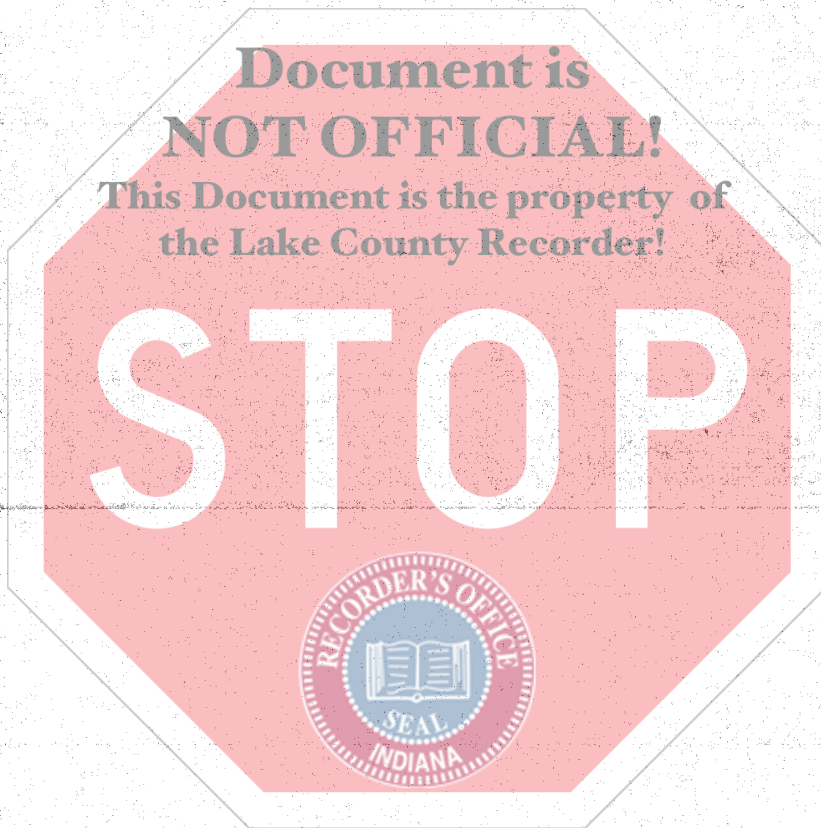

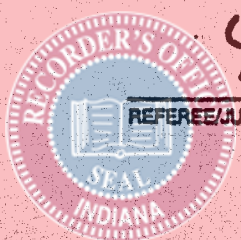
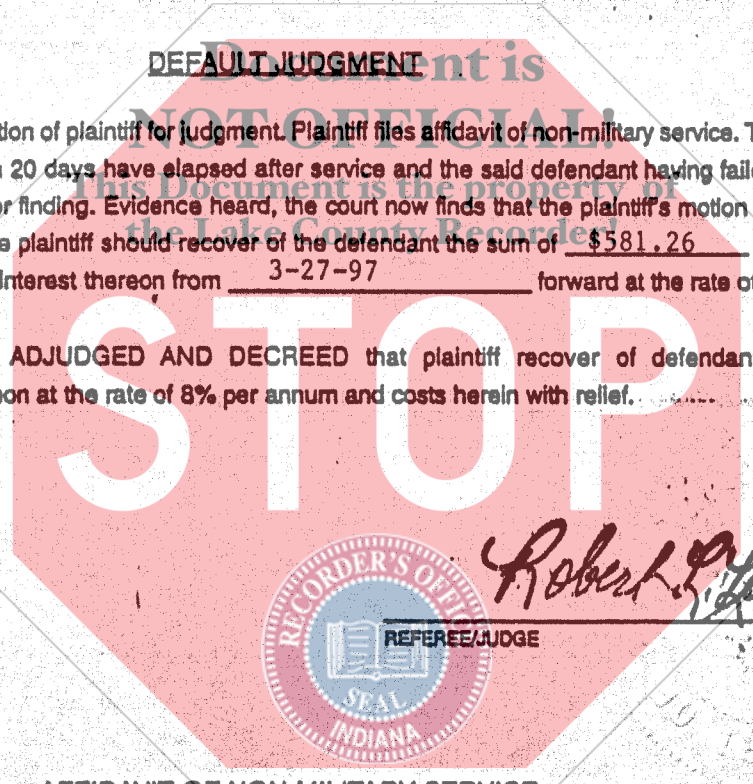

DEFAULT JUDGMENT

This cause came on trial upon application of plaintiff for judgment. Plaintiff files affidavit of non-military service. The plaintiff shows proof of service of its complaint and more than 20 days have elapsed after service and the said defendant having failed to appear or dispute its claim, this cause is now submitted for finding.
