of Indiana, to wit:

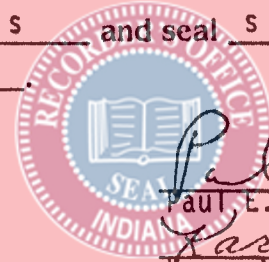
Part of Lot 25, Union Addition to the Town of Lowell, as shown in
