POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

Indemnity, in all cases where indemnity may be lawfully given; and with full power and authority to execute consents and waivers to modify or change or extend any bond or document executed for this Company, and to compromise and settle any and all claims or demands made or existing against said Company.

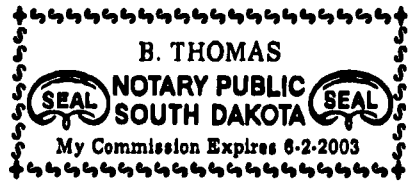
