THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unpaid balance of said indebtedness is ONE HUNDRED THOUSAND SIX HUNDRED FIFTY SEVEN AND 26/100 DOLLARS (\$100,657.26) all of which the undersigned promises to pay with interest at 7.000% per annum until paid, and that the same shall be payable at Six Hundred Eighty and 24/100 Dollars (\$680.24), per month beginning on the 1st day of December, 1998, to be applied to interest, and the balance to principal, and that in all respects said mortgage contract shall remain in full force and effect.

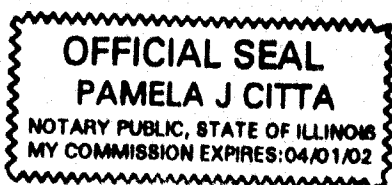
