**NOTICE OF LIEN RIGHTS**

YOU ARE HERBY NOTIFIED that LUMBER 1, LLC, 1014 - 165<sup>th</sup> Street, Hammond, Indiana, furnished material and/or labor for the original construction of a single or double family dwelling to be or being constructed on the property located at 2725 Martha Street, Highland, Indiana, and legally described as follows:

*Part of 2nd 1/2 Sec. 16, T. 36 N., R. 9 W. of 2nd P.M. Township 36 N., Range 9 W. of 2nd P.M. Beginning at a point on the N. line of Martha St., said point being 180.71 feet South and 375 feet West of the SW corner of Hook's 2nd addition to Highland; thence N., parallel to the East line of said West half of said Section, 203.29 feet to the South line of Hook's 2nd addition; thence westerly on said South Line 100.58 feet; thence South 209.31 feet to the place of beginning, in the Town of Highland, Lake County, Indiana*
