Lot 6 in Block 3 in Oak Center Addition, as per plat thereof, recorded in Plat Book 23 page 46, in the Office of the Recorder of Lake County, Indiana.

2. The marital relationship which existed between Myrna L. Miller and William R. Miller, continued unbroken from the time they so acquired title to said real estate until the death of Myrna L. Miller on 11-26-98 at which time William R. Miller acquired title as surviving tenant by the entirety.

3. That the gross value of the estate of the said Myrna L. Miller, deceased, taking into consideration in the evaluation thereof, the value of all her gifts in contemplation of death, including all gifts made by her in the three years next preceding her death, together with the value of all of her investments in joint properties and tenants by the entirety, including the real estate in the above-described deed, plus the proceeds of all insurance on her life, did not equal or exceed the sum required to necessitate the filing of a federal estate tax return and that as a consequence of which, her estate was not subject to federal estate tax.
