

SPECIAL AND LIMITED POWER OF ATTORNEY AND COVENANTS

KNOW ALL MEN BY THESE PRESENTS:

In connection with the servicing of second mortgage loans (as defined in the Servicing Agreement hereafter described, each a "Mortgage Loan" and collectively, the "Mortgage Loans") under that certain Loan Servicing Agreement dated as of June 19, 1997, the ("Servicing Agreement"), by and between Commercial Federal Bank, as the successor in interest to AmerUs Bank ("Owner") and First Bank Richmond, N.A., formerly First Bank Richmond, S.B. ("Servicer"), Owner does hereby constitute and appoint Servicer as true and lawful attorneys for Owner (but only for the purpose set forth herein) and pursuant to Section 4.1 of the Servicing Agreement hereby authorizes and empowers each such attorney, for and in the name and stead of Owner to endorse, execute or deliver any and all documents or instruments of satisfaction or cancellation, or of partial or full release or discharge, and all other comparable instruments, with respect to the Mortgage Loans, all in accordance with the terms of the Servicing Agreement, including, without limitation, the recording or filing with the appropriate public officials of such documents or instruments and the endorsement and deposit of any such instrument in connection with the foreclosure of any Loan or the bankruptcy or receivership of the Obligor of any Loan. Capitalized terms used and not otherwise defined herein shall have the respective meanings ascribed to such terms in the Servicing Agreement.

Owner covenants and agrees that it shall, from time to time after the date hereof, at the request of Servicer, execute instruments confirming all of the foregoing authority of any of the attorneys or substitute attorneys. The foregoing shall not be deemed to be breached by reason of any action or omission of any of the attorneys or such substitute attorneys as may be appointed hereunder.

This power of attorney is revocable by Owner.
