RELEASE AND SATISFACTION OF MORTGAGE ORDER

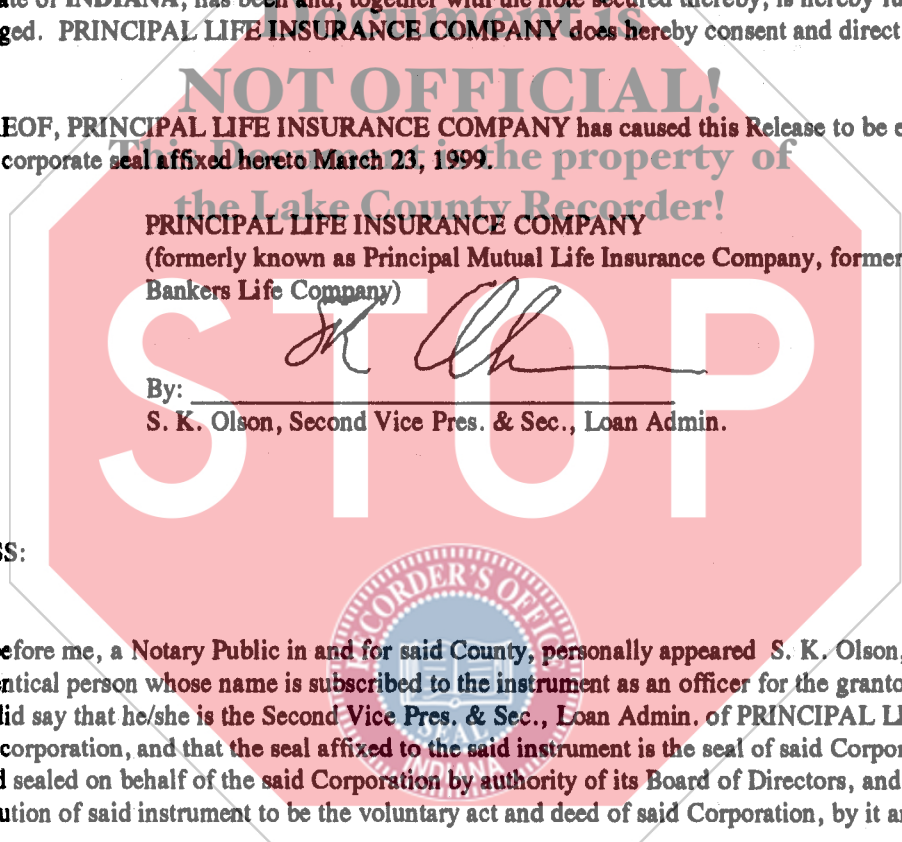


