# TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 23<sup>rd</sup> day of September, 1998 produce to the County of Lake in the State of Indiana, a certificate of sale dated the 23<sup>rd</sup> day of September, 1998 signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that said County on the 13<sup>th</sup> day of February, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of \$00.00, being the amount due on the following tracts of land returned delinquent in the name PROGRESSIVE COMMUNITY CLUB, INC. for 1996 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given. It appearing that Lake County is the owner of the certificate of sale, that the time for redeeming such real property has expired, that the property has not been redeemed, that PROGRESSIVE COMMUNITY CLUB, INC.
