# TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 23<sup>rd</sup> day of September, 1998 produce to the County of Lake in the State of Indiana, a certificate of sale dated the 23<sup>rd</sup> day of September, 1998 signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that said County on the 13<sup>th</sup> day of February, 1999 obtained, pursuant to law, the real property described in this indenture for the sum of \$00.00, being the amount due on the following tracts of land returned delinquent in the name LUCIOUS ROBERT for 1996 and prior years, namely:

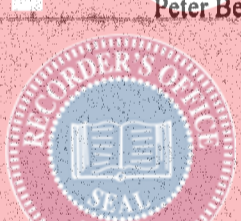
