TAX TITLE DEED TO COUNTY

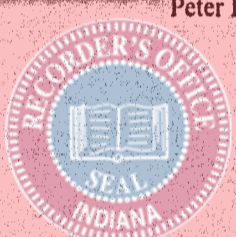
