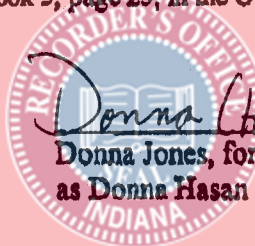

Hasan and Yahiya "Steve" Hasan

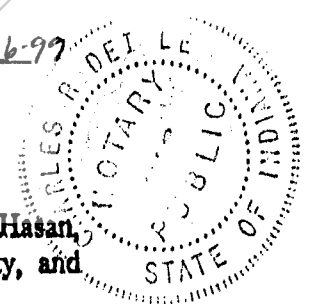
Donna Hasan, now (since dissolution of marriage) known as Donna Jones, is aware that she has judgment liens in her favor and against her ex-husband, Yahiya "Steve" Hasan, as entered in the above-referenced dissolution of marriage action, including a judgment lien for one-half of the equity in the real property located at 1101-1103 Sibley St., Hammond, IN, as of Feb. 1, 1999; a judgment lien for one-half of the balances, as of Feb. 1, 1999, in Yahiya "Steve" Hasan's SandRidge Bank account; and a judgment lien for \$1000.00 (for "a reliable vehicle").

As Yahiya "Steve" Hasan has explained to me and I verily believe that there is no equity in the 1101-1103 Sibley Street property and that there are no funds in Sand Ridge Bank accounts of Yahiya "Steve" Hasan (as of Feb. 1, 1999) and as Yahiya "Steve" Hasan has executed an Agreement to Pay Judgment (\$1000.00) by Installment Payments, all of which is satisfactory and acceptable to me, I, Donna (Hasan) Jones, hereby release from my judgment liens the real property of Yahiya "Steve" Hasan located at 1101-1103 Sibley St., Hammond, IN, only, which parcel is legally described, as follows:
