FIRST: I revoke all former wills and codicils that I have previously made.

SECOND: I give, devise, and bequeath the following money or personal property:

I also bequeath my automobile, listed above, to Adam Quarles of Hammond, IN

The following personal household items are to be divided among family members as they see fit

4. Beside Table
5. Chest with mirror
6. Three oak Buffets
7. Oak Table with all chairs
8. Telephone Table

The rest of the personal property is to be sold and liquidated into cash and disbursed as foretold above.

THIRD: I direct all my just debts and funeral expenses be paid as soon as possible after my death.
