To exercise due difigence in the operation, management, and occupation of said real enters and the improvements thereon and not to remove or suffer to be removed any fusture(s) and/or application), now or hereafter placed on said premises; and to keep said real estate and improvements thereon in their present condition and repair, normal and ordinary depreciation excepted; Mortgagor shall not do or suffer to be done any acts which will impair the accurrity of this mortgage nor any illegal or immoral acts on said premises; and Mortgagoe shall have the right to inspect said premises at all reasonable times.
- 3. The holder of this obligation may renew the same or extend the time of payment of the indebtodness or any part thereof or reduce the payments thereon; and any such renewal, extension, or reduction shall not release any maker, endorser, or guarantor from any liability on said obligation.
- 4. No sale of the premises hereby mortgaged or extension of time for the payment of the debt hereby secured shall operate to release, discharge, or modify in any manner the effect of the original liability of the Mortgagor, and any extension of time on this Mortgage by Mortgage or his assigns, without the content of the holder of any junior time or encambrance, shall not operate to cause a test of the priority of this Mortgage over such junior time. Mortgage shall be subrogated to any lies or claim paid by moneys advanced and hereby secured.

5. In case any part of the premises is appropriated under the power of eminent domain, the entire amount paid for said portion of the premises so appropriated shall be paid to this Mortgages.

6. It is agreed that time is the essence of this agreement and that, in case of default in the payment of any installment when the same shall become due and payable, the holder of the note and Mortgage may, at his option, doclare all of the debt due and payable; and any fullier to exercise said option shall not constitute a weiver of right to exercise the same at a later date. In the event any proceedings shall be instituted on any junior line or encumbrance against said real entate, then the Mortgagee herein may immediately declare this Mortgage due and payable and institute such proceedings at may be necessary to protect his interest. The lice of this Mortgage shall include all heating, planthing, lighting, or other futures now or hereafter attached to or used in connection with said premises.

7. In case of delinquency or default in any payment required in this Mustage and the institution of foreclosure proceedings thecreunder, Mortgages is expressly authorized to cause a continuation of the abstract of title at the expense of Mortgager to show the condition of the title at the date of said continuation and which sums necessarily spent for the continuation of the abstract of title to the said real entire, together with interest thereon at the rate of percent per annum, shall become part of the debt secured by this Mortgage and collectible as such; and in case of foreclosure and purchase of said real entate pursuant to said foreclosure by the holder thereof, the abstract of title and any continuation thereof shall be the absolute property of the Mortgages.

In the event of such foreclosure, the Morgages, or his assigns, may apply for the appointment of a receiver, which receiver is hereby authorized to take possession of the said real estate; collect the rents, income or profit, in money or is kind; and hold the proceeds subject to the order of the court for the benefit of the Mortgagee pending foreclosure proceedings. Said receiver may be appointed irrespective of the value of the mortgaged property or its adequacy to secure or discharge the indebtedness due or to become due.
