THIS INDENTURE WITNESSETH, That Lantz Development Corp., an Indiana corporation (Grantor)

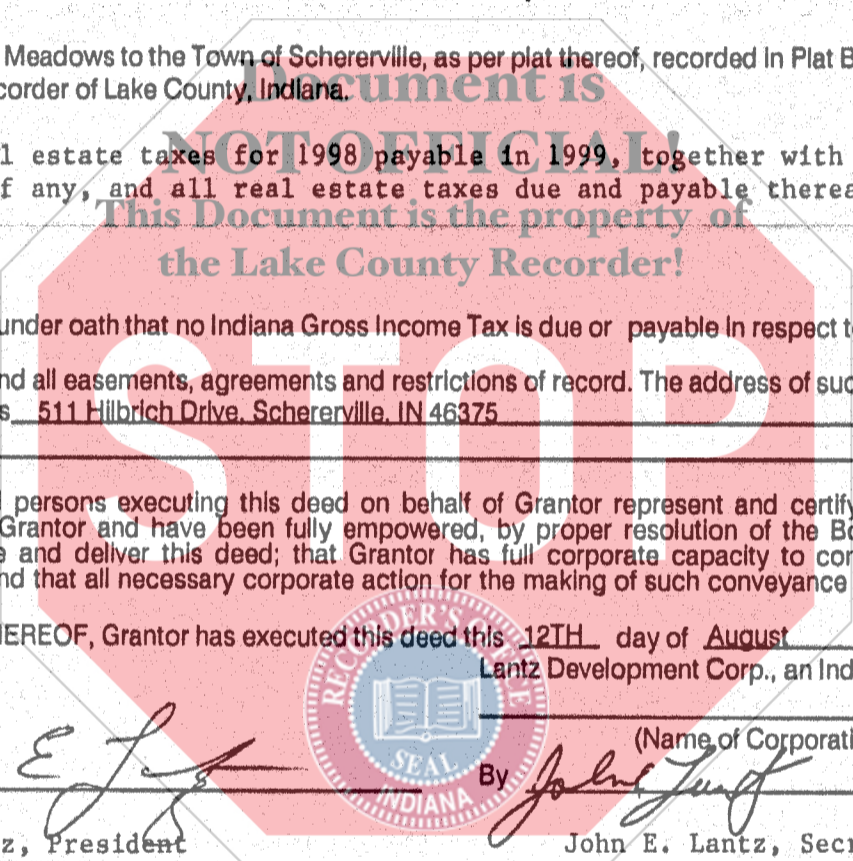

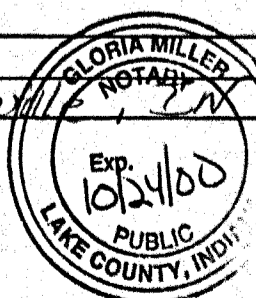
