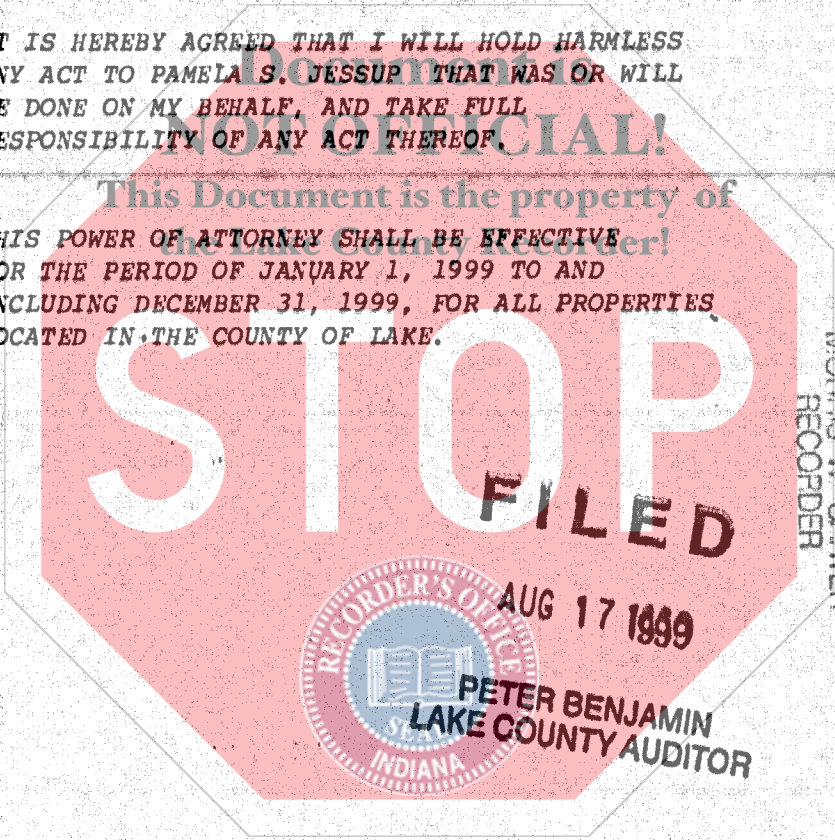
Know All Men by These Presents, That GERARD M. DRAPAC, A SINGLE MAN

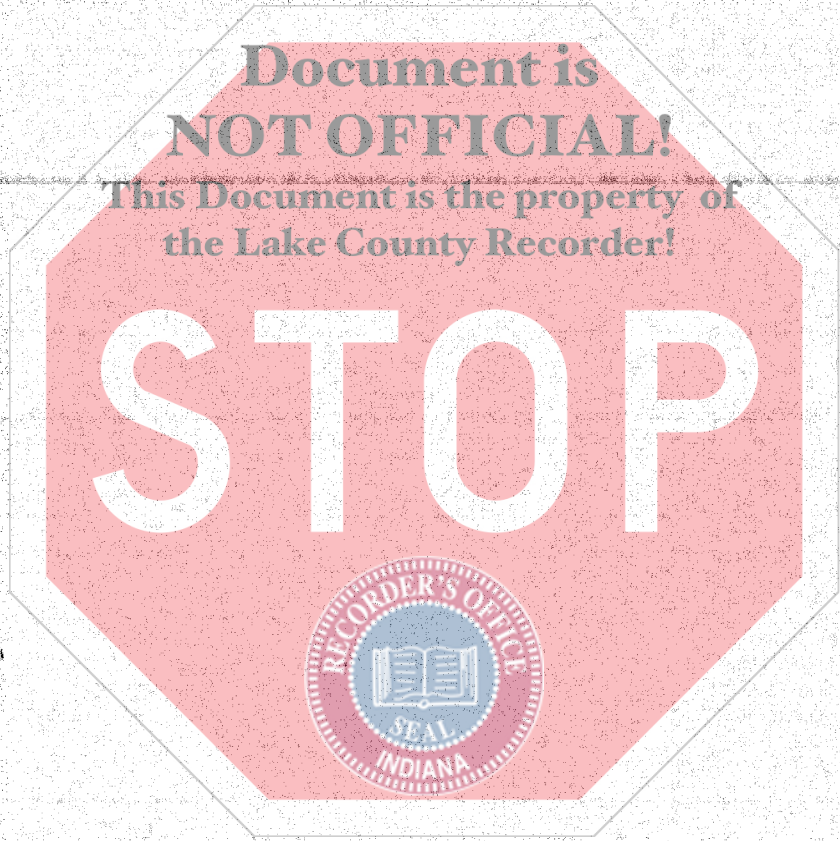
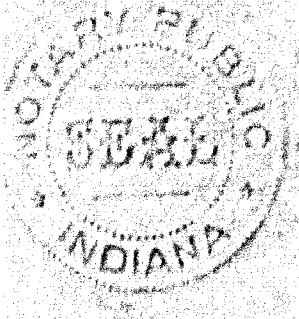
