## TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 2<sup>nd</sup> day of August, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 23<sup>rd</sup> day of September, 1998 signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that said County on the 23<sup>rd</sup> day of September, 1998 obtained, pursuant to law, the real property described in this indenture for the sum of Seven Thousand Nine Hundred sixty-one dollars and ninety two cents (\$7,961.92), being the amount due on the following tracts of land returned delinquent in the name JACKSON CHARLES E for 1996 and prior years, namely:

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given.
