TAX TITLE DEED TO COUNTY

WHEREAS, Lake County did, on the 2nd day of August, 1999 produced to the County of Lake in the State of Indiana, a certificate of sale dated the 23rd day of September, 1998 signed by Sam Orlich who, at the date of sale, was Auditor of the County, from which it appears that said County on the 23rd day of September, 1998 obtained, pursuant to law, the real property described in this indenture for the sum of Forty Two Thousand Three Hundred ninety dollars and sixty nine cents (\$42,390.69), being the amount due on the following tracts of land returned delinquent in the name LEWIS WILLIAM for 1996 and prior years, namely:

LOT'S 21, 22 AND THE NORTH 2 FEET OF LOT 23, BLOCK 2, SCHUG PARK SOUTH BROADWAY ADDITION TO GARY, IN THE CITY OF GARY, AS SHOWN IN PLAT BOOK 8, PAGE 9, IN THE OFFICE OF THE RECORDER OF LAKE COUNTY, INDIANA.

Such real property has been recorded in the Office of the Lake County Auditor as delinquent for the nonpayment of taxes and proper notice of the sale has been given. It appearing that Lake County is the owner of the certificate of sale, that the time for redeeming such real property has expired, that the property has not been redeemed, that the Lake County Commissioners have demanded a deed for the real property described in the certificate of sale, that the records of the Lake County Auditor's Office state that the real property was legally liable for taxation, and the real property has been duly assessed and properly charged on the duplicate with the taxes and special assessments for 1997 and prior years.
