### QUITCLAIM DEED

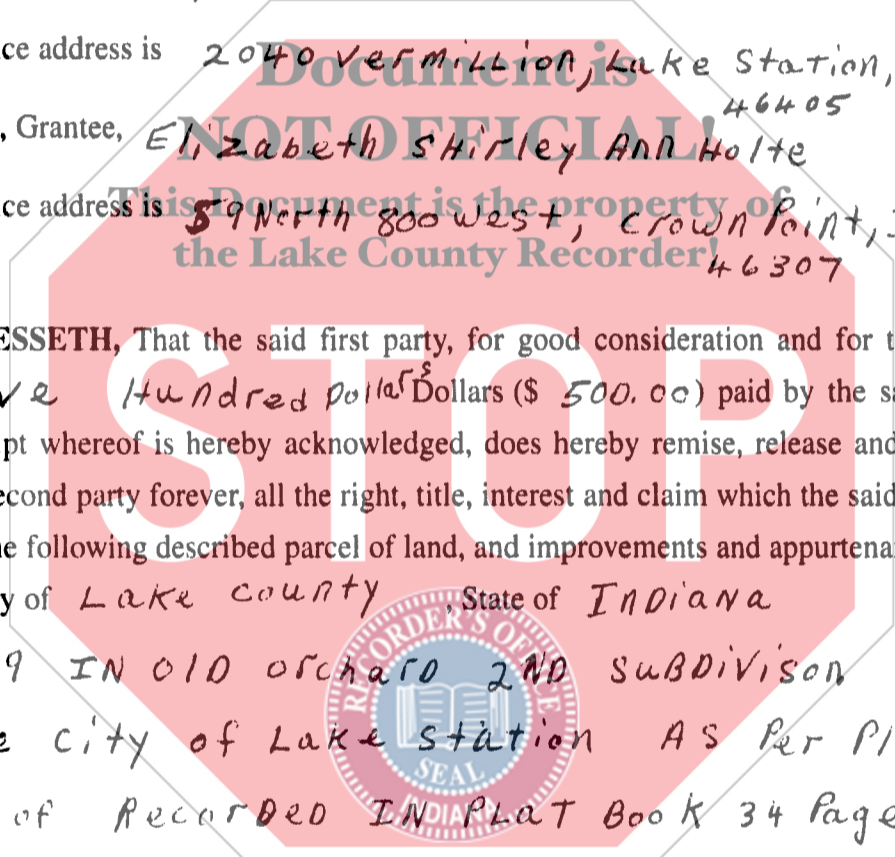
