"Article V, Section 13. - FIDELITY AND SURETY BONDS ... the President, any Vice President, the Secretary, and any Assistant Vice President appointed for that purpose by the officer in charge of surety operations, shall each have authority to appoint individuels as attorneys-in-fact or under other appropriate titles with authority to execute on behalf of the company fidelity and surety bonds and other documents of similar character issued by the company in the course of its business... SEARS, ROEBUCK AND CO. HOFFMAN ESTATES, ILLINOIS APPOINTMENT AND DESIGNATION OF AUTHORITY

Pursuant to the resolutions of the Board of Directors of Sears, Roebuck and Co., dated May 14, 1998, the undersigned hereby appoints **Janet Stage** to the office of Assistant Secretary of the Company, to serve in said office from May 14, 1998, and until the last day of the month in which the next annual meeting of shareholders of Sears, Roebuck and Co. is held or until such other time as the undersigned or his duly appointed successor may hereafter direct in writing.

The undersigned further designates to Janet Stage, for such time as she reports to me or my duly appointed successor, the authority to execute and deliver, on behalf of the Company, the documents listed below:

- · applications, reports and affidavits required under state workers' compensation laws;
- corporate surety bonds, indemnity bonds and other bid bonds, and performance bonds, sign license bonds and other miscellaneous bonds and indemnity agreements required by state or local law, in order to secure a license or privilege for the Company;
- bonds required under state workers' compensation laws;
- corporate bid and performance bonds and personal bid and performance bonds in connection with the sale of merchandise to industrial, commercial, governmental and other purchasers;
- releases, affidavits and other instruments necessary or desirable in connection with the corporate insurance program or with effecting recoveries of or for lost or damaged property; and
- contracts, agreements, documents and instruments relating to the purchase of loss control and loss prevention products and services necessary or desirable in connection with the corporate insurance program

This designation does not include authority to sign contracts that extend for more than one year or bonds in excess of One Million Dollars (\$1,000,000).

The above named person shall hold the office designated above at the will of the undersigned and subject to his or his duly appointed successor's further direction and shall perform such duties as may be prescribed from time to time by appropriate officers of the Company.

The foregoing designation cancels and supersedes any prior appointments and designations to the above-referenced person.
