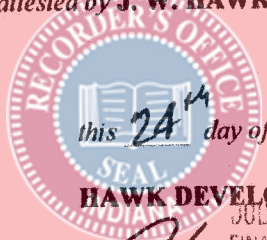
THIS DEED TAKEN SUBJECT TO:
