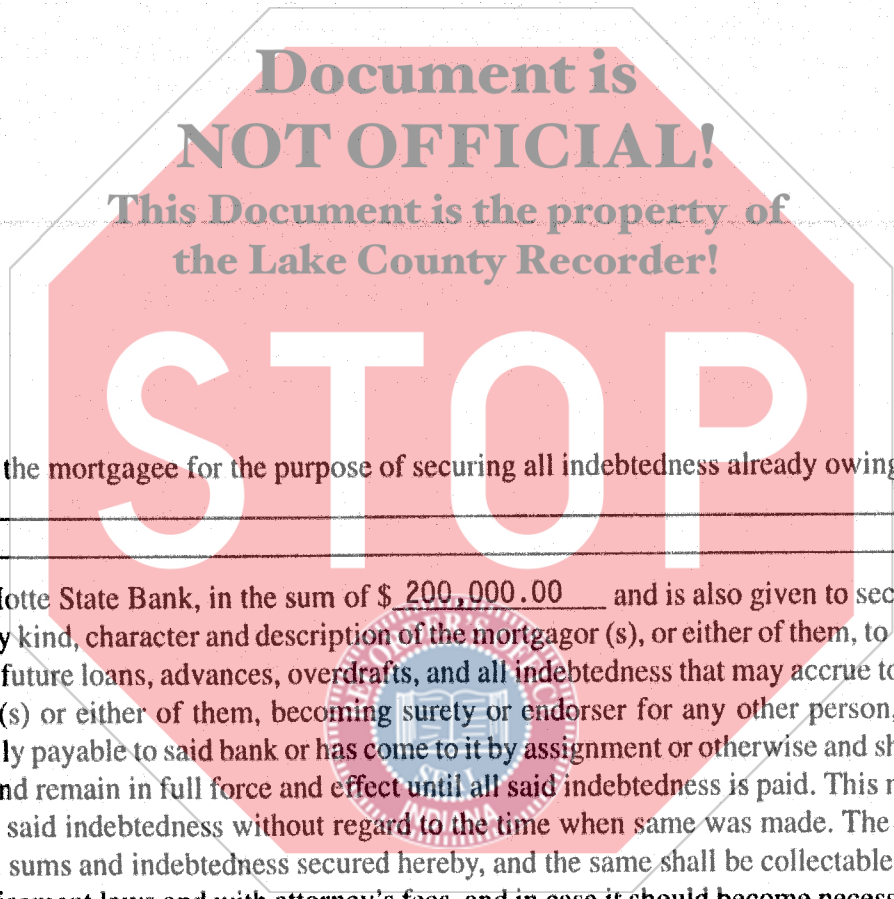
**INDEMNIFYING MORTGAGE**
