however, this bond may be continued from year to year by continuation certificate executed by said Surety.

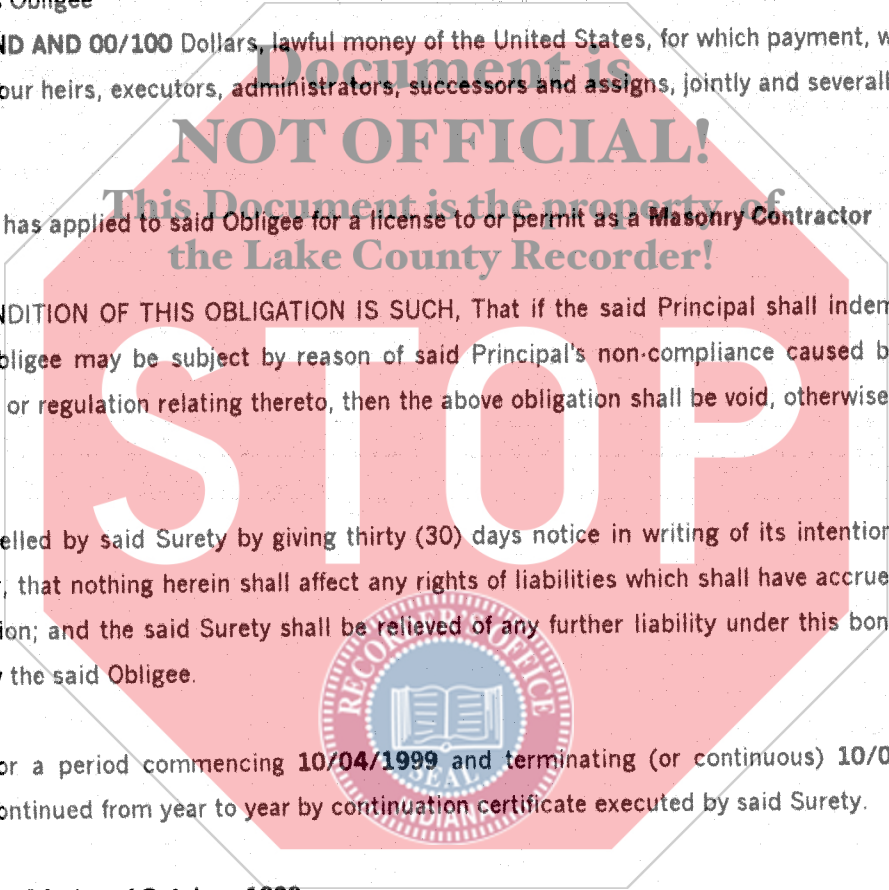
