**RELEASE AND SATISFACTION OF MORTGAGE**

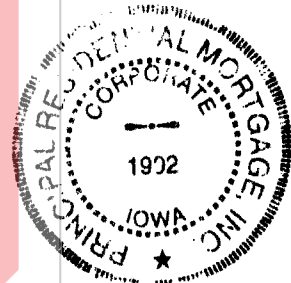
