to secure the repayment of a promissory note of even date in the sum of \$15,435,00 , payable to Mortgagee in monthly installments, the last payment to fall due on NOVEMBER 6, , 2003 , and also to secure the repayment of any and all future advances and sums of money which may from time to time hereafter be advanced or loaned to Mortgagors by Mortgagee; provided however, that the principal amount of the outstanding indebtedness owing to Mortgagee by Mortgagors at any one time, shall not exceed the sum of \$125,000.00.
