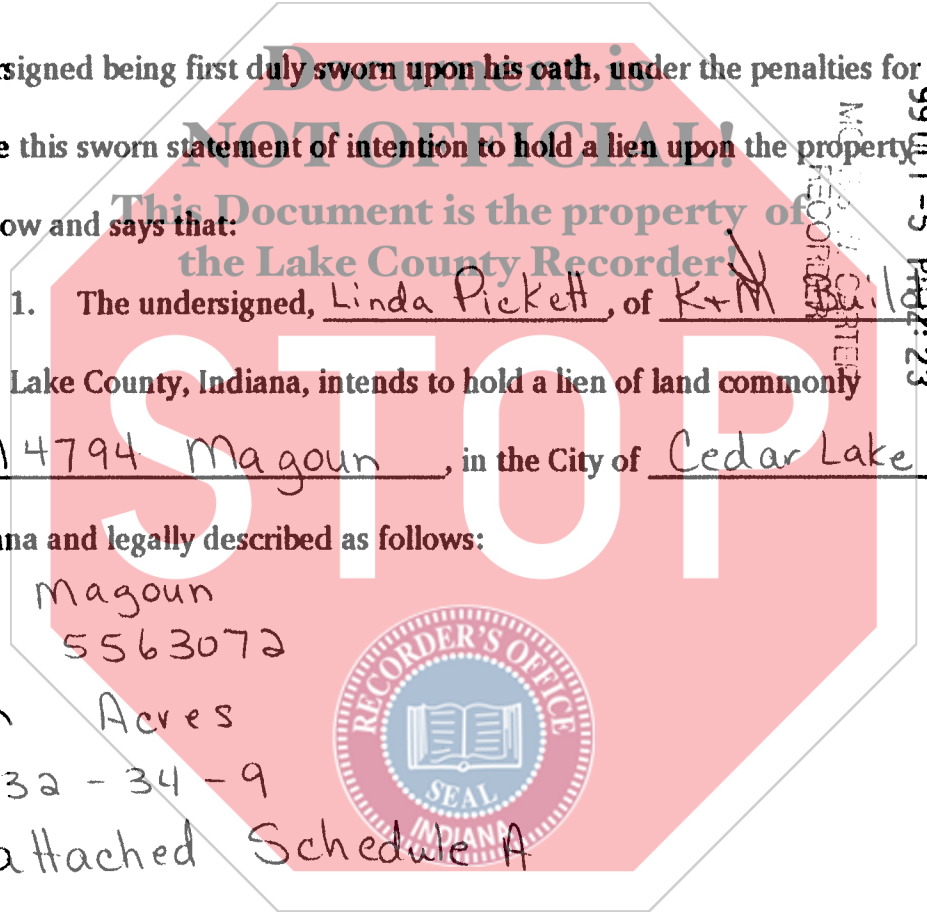

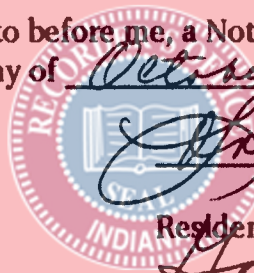

LEGAL DESCRIPTION

PARCEL 1: The Southeast 1/4 of the Southwest 1/4 of Section 32, Township 34 North, Range 9 West of the 2nd Principal Meridian, except: Commencing at the Southeast corner thereof, thence North 550 feet; thence Southwesterly to a point 160 feet North and 150 feet West of the place of beginning; thence South to the South line of said 1/4 1/4 Section, thence East to the place of beginning.

PARCEL 2: Part of the Northeast 1/4 of the Southwest 1/4 of Section 32, Township 34 North, Range 9 West of the 2nd Principal Meridian, described as commencing at the Southeast corner thereof and running thence North 769.30 feet to the Northeast corner of the 12 1/2 acres set off to Jacob Beckley in Partition Suit Decree entered in Cause No. 3, Common Pleas Court, in Order Book "A", page 173, thence West along the North line of said 12 1/2 acre tract 752.06 feet to the East line of the West 4 1/2 acres of said 12 1/2 acre tract, thence South along said East line 514.79 feet to the North line of the 4 1/2 acre tract set off in said Partition to Catherine Beckley, thence West along said North line 380.03 feet to the East line of the 5 1/2 acre tract set off in said partition suit to Charles Beckley, thence South along said East line 254.51 feet to the South line of the Northeast 1/4 of the Southwest 1/4 of said Section; thence East 1131.23 feet to the place of beginning. Also except that part of the Northeast 1/4 of the Southwest 1/4 of Section 32, Township 34 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana, described as follows: Commencing at the Southeast corner thereof; thence North 0 degrees 15 minutes 24 seconds East (assumed bearing) along the East line thereof, 448.50 feet to the place of beginning; thence continue North 0 degrees 15 minutes 24 seconds East along said East line 337.37 feet to the Northeast corner of the 12 1/2 acres set off to Jacob Beckley in Partition Suit Decree entered in Cause No. 3. Common Pleas Court, in Order Book "A", page 173; thence North 84 degrees 26 minutes 30 seconds West along the North line of said 12 1/2 acre tract 300.0 feet to the Northeast corner of a tract conveyed to Gene and Carol Swart in a deed dated December 2, 1982 and recorded December 23, 1982 as Document No. 691354, in the Office of the Recorder of Lake County, Indiana;
