The undersigned, being all of the heirs of the above estate agree and state as follows:

- 1. That Bishop Q.C. Garmon died intestate on January 15, 1991 and the Lemuel Garmon was appointed personal representative of the estate in 1993.
- 2. That pursuant to the laws of the State of Indiana, all surviving heirs of Bishop O.C. Garmon would be entitled to 1/6th of the estate.
- 3. That the personal representative of the estate has secured appraisals of the household goods, furnishings, jewelry, automobiles, and other intangible personal property of the estate; the parties have further agreed that because of the "run-down" state of the real property located at 2053 Pennsylvania Street, Gary, Indiana, a value of \$5000 should be assigned to it.
- 4. The public sale of the estate's real or personal property is not in the best interest of the heirs and that an alternative to a public sale would be the purchase by the heirs of the various items of real and personal property.
