03-28-95 The State of Indiana appears by Deputy Prosecuting Attorney Diane Boswell. The defendant appears in person with Public Defender David Olson. Cause submitted for **ACCEPTANCE OF PLEA AND SENTENCING**. Evidence and arguments are heard on plea agreement and sentencing. Court now accepts said plea agreement and finds the defendant guilty of Sexual Battery, a Class D Felony.

Cause submitted for **SENTENCING**. The Court being duly advised and having considered the written presentence investigation report, now sentences the defendant on conviction of the crime of Sexual Battery, a Class D Felony, to a term of one and one-half (1-1/2) years. Court now suspends all but 150 days, defendant to serve 150 days and one and one-half (1-1/2) years probation. The reason for the imposition of the sentence is the Court finds in mitigation that 1) the defendant has no record of criminal convictions and 2) the defendant's youthful age of 18 years.

Defendant ordered committed to the Lake County jail and is to receive credit for 17 days spent in confinement awaiting disposition of the herein cause.

Court costs are imposed, as well as a child abuse fee in the amount of \$50. The Court further imposes an initial probation users' fee in the amount of \$25 and an additional fee of \$5 per month.

Defendant is advised of his right to file a Post Conviction Relief Petition under the Indiana Rule of Procedure for Post Conviction Remedies.


