law.

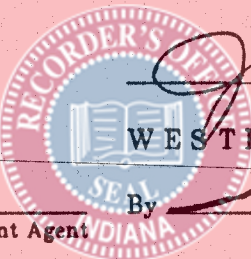

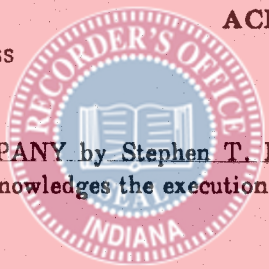
