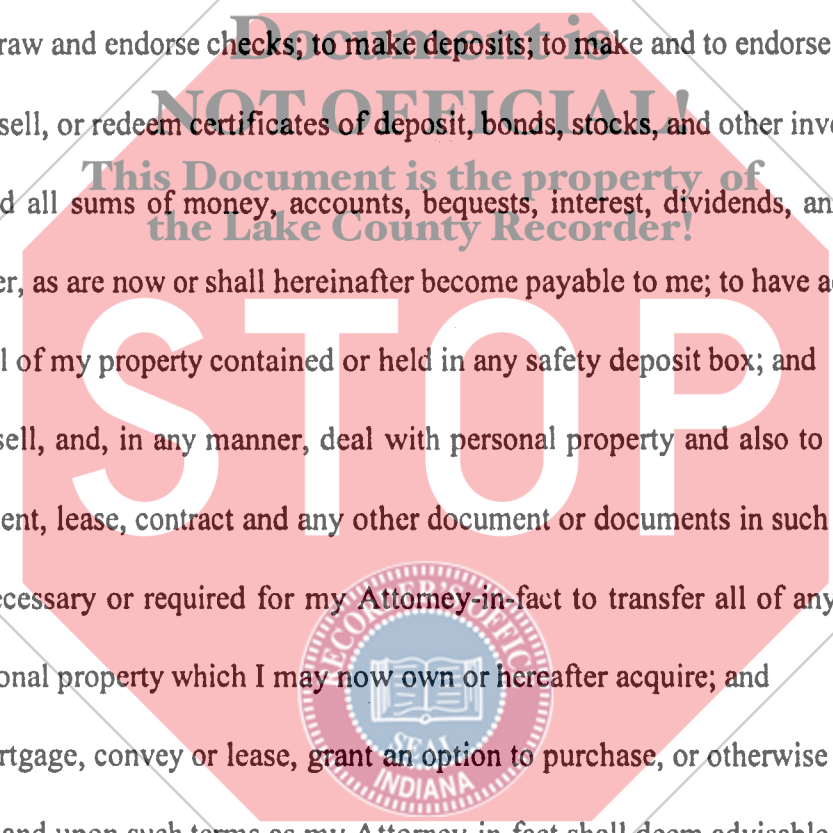
**GENERAL DURABLE POWER OF ATTORNEY**

I, **THELMA MAE JONES**, of Lake County, State of Indiana, do hereby appoint my daughter **NORMA HUNTER**, to be my true and lawful Attorney-in-fact, for me and in my name, place and stead to draw and endorse checks; to make deposits; to make and to endorse promissory notes; to purchase, sell, or redeem certificates of deposit, bonds, stocks, and other investments; to receive and demand all sums of money, accounts, bequests, interest, dividends, annuities, and demands whatsoever, as are now or shall hereinafter become payable to me; to have access to and to remove any or all of my property contained or held in any safety deposit box; and

To buy or sell, and, in any manner, deal with personal property and also to execute and deliver any agreement, lease, contract and any other document or documents in such manner and form as may be necessary or required for my Attorney-in-fact to transfer all of any part of my interest in any personal property which I may now own or hereafter acquire; and

To sell, mortgage, convey or lease, grant an option to purchase, or otherwise transfer, for such consideration and upon such terms as my Attorney-in-fact shall deem advisable, including a contract for conditional sale, and also to execute and deliver any deed, sales agreement, lease, contract and any other document or documents in such manner and form as may be necessary or required for my Attorney-in-fact to transfer all of any part of my interest in real property which I may now own or hereafter acquire; and

To execute and file all tax returns of any kind whatsoever, and to pay such taxes as are required by the United States, any state, or political subdivision thereof; and to examine and request copies of any tax returns heretofore filed by me or for and on my behalf; and

To pay any and all expenses incident to my care, support, health, welfare and maintenance, or required to discharge any obligation, account, tax or other indebtedness for which I am responsible; and

To employ agents or other persons in connection with the performance of these delegated powers as my Attorney shall see fit; and

Generally to transact any and all business for me of any kind and nature whatsoever necessary or proper to be done in matters affecting my property, including the institution, prosecution, compromise or settlement of legal proceedings, with the same force and effect as though I were personally present and acting myself.

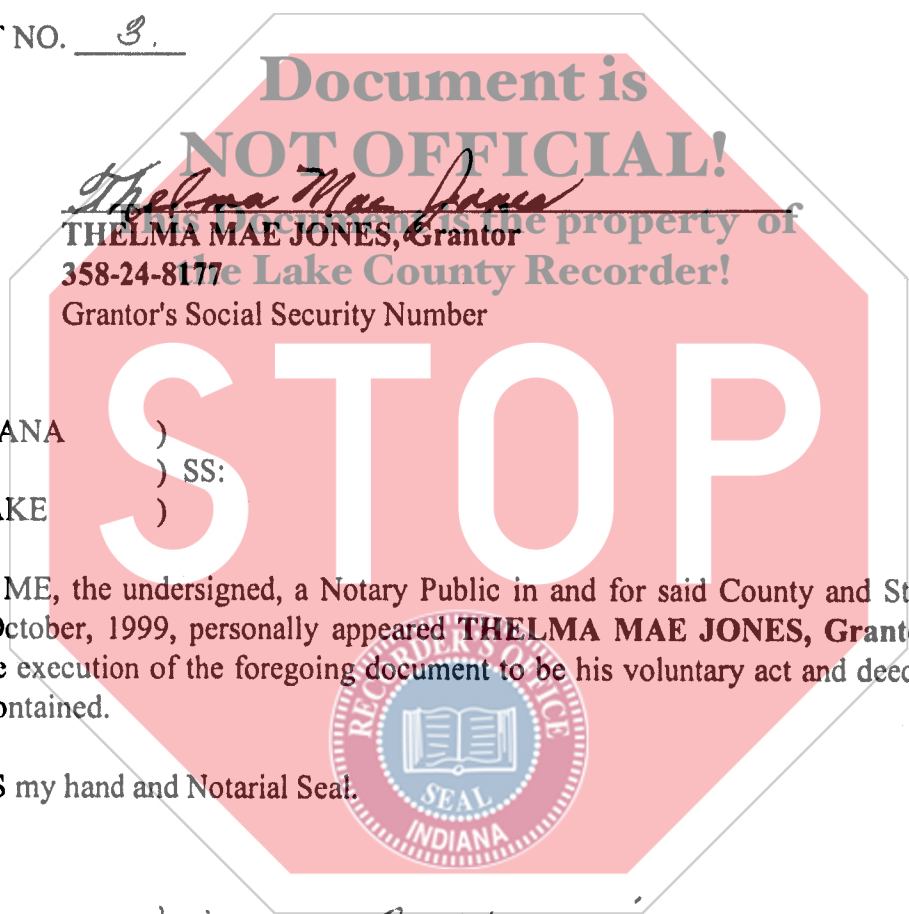
In furtherance of these powers, I give my Attorney-in-fact the power and authority to do for me and in my name those things which such Attorney deems expedient and necessary to effectuate the intent of this instrument, as fully as I could do personally for myself, **reserving unto myself, however, the power to act on my own behalf and also to revoke the powers given in this instrument.**

If protective proceedings for my person and/or estate shall be commenced, I hereby nominate my daughter, **NORMA HUNTER**, as Guardian of my person and/or estate, as the case may be, to serve without bond to the full extent permitted by law.

This Power of Attorney shall not be affected by my subsequent disability or incapacity, nor by lapse of time, it being my intention that this instrument constitute a durable power of Attorney under the Indiana Uniform Durable Power of Attorney Act.
