



**LEGAL DESCRIPTION**

East 88 feet of part of the East half of the Northeast Quarter of Section 20, Township 35 North, Range 7 West of the Second Principal Meridian in Lake County, Indiana more particularly described as follows: Beginning at a point on the North line of U.S. Highway No. 30 and 685.13 feet West of the East line of said Section 20 measured along the North line of said highway; thence North, parallel to the West line of the East half of the Northeast Quarter of said Section 20, a distance of 577.42 feet; thence East at right angles at a distance of 358.09 feet; thence South parallel to the West line of the East half of the Northeast Quarter of said Section 20, a distance of 581.61 feet; thence West, a distance of 358.10 feet to the point of beginning.
