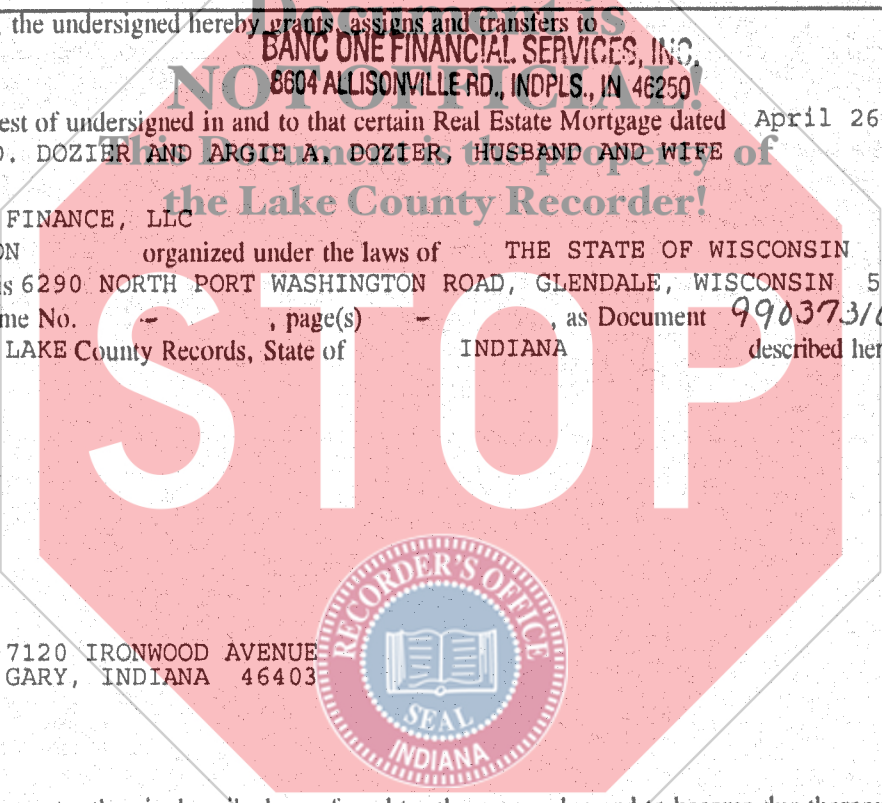

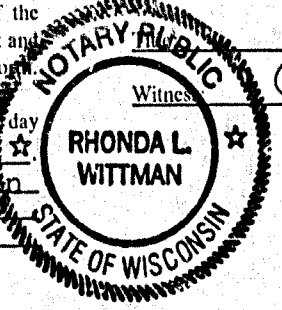

ALL THAT PART OF LOTS 7 AND 8, IN BLOCK "D", IN CRUMPACKER LAKE VIEW ADDITION, IN THE CITY OF GARY, AS SHOWN IN PLAT BOOK 15, PAGE 27, LAKE COUNTY, INDIANA, MORE PARTICULARLY DESCRIBED AS: LYING BETWEEN THE TWO FOLLOWING DESCRIBED EAST AND WEST LINES: A STRAIGHT LINE BEGINNING AT A POINT ON THE EASTERLY LINE OF SAID LOT 7, WHICH IS 70 FEET SOUTHERLY MEASURED ALONG SAID EASTERLY LINE FROM THE NORTHEAST CORNER OF SAID LOT 7 AND EXTENDING NORTHWESTERLY TO THE WESTERLY LINE OF SAID LOT 7 (WHICH EXTENDED LINE INTERSECTS A STRAIGHT LINE DRAWN FROM THE MOST NORTHERLY CORNER OF SAID LOT 7 TO THE MOST NORTHERLY CORER OF LOT 1, IN SAID BLOCK "D", AT A POINT 46 FEET SOUTHERLY MEASURED ALONG SAID LINE SO INTERSECTED FROM THE MOST NORTHERLY CORNER OF SAID LOT 7) AND A STRAIGHT LINE BEGINNING AT A POINT ON THE EASTERLY LINE OF SAID LOT 8, WHICH IS 160 FEET SOUTHERLY MEASURED ALONG THE EASTERLY LINE OF SAID LOTS 7 AND 8, FROM THE NORTHEAST CORNER OF SAID LOT 7, AND EXTENDING NORTHWESTERLY TO THE WESTERLY LINE OF SAID LOT 8 (WHICH EXTENDED LINE INTERSECTS A STRAIGHT LINE DRAWN FROM THE MOST NORTHERLY CORNER OF SAID LOT 7 TO THE MOST NORTHERLY CORNER OF LOT 1, IN SAID BLOCK "D", AT A POINT 128 FEET SOUTHERLY MEASURED ALONG SAID LINE SO INTERSECTED FROM THE MOST NORTHERLY CORNER OF SAID LOT 7).
