7. DUE ON SALE. Lender may, at its option, declare the entire balance of the Secured Debt to be immediately due and payable upon the creation of, or contract for the creation of, a transfer or sale of the Property. 8. DEFAULT. Mortgagor will be in default if any of the following occur:

9. REMEDIES ON DEFAULT. 15. NOTICE.
