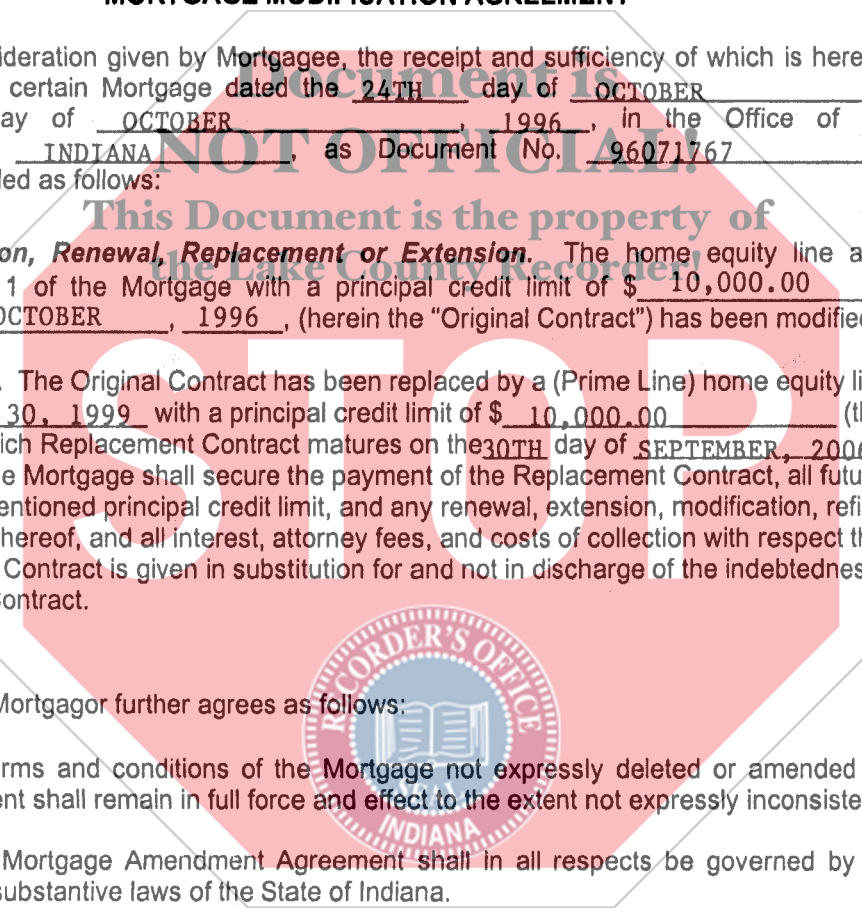

**MORTGAGE MODIFICATION AGREEMENT**

Mortgagor, for valuable consideration given by Mortgagee, the receipt and sufficiency of which is hereby acknowledged, does hereby agree that the certain Mortgage dated the 24TH day of OCTOBER, 1996, recorded the 29TH day of OCTOBER, 1996, in the Office of the Recorder of LAKE County, INDIANA, as Document No. 96071767 (herein the "Mortgage"), is hereby amended as follows:



1. **Contract Modification, Renewal, Replacement or Extension.** The home equity line account (Contract) referenced on page 1 of the Mortgage with a principal credit limit of \$ 10,000.00 and dated the 24TH day of OCTOBER, 1996, (herein the "Original Contract") has been modified as follows:
  - 1.1. **Replacement.** The Original Contract has been replaced by a (Prime Line) home equity line account dated SEPT. 30, 1999 with a principal credit limit of \$ 10,000.00 (the "Replacement Contract") which Replacement Contract matures on the 30TH day of SEPTEMBER, 2006. Mortgagor agrees that the Mortgage shall secure the payment of the Replacement Contract, all future advances up to the aforementioned principal credit limit, and any renewal, extension, modification, refinancing or replacement thereof, and all interest, attorney fees, and costs of collection with respect thereto. The Replacement Contract is given in substitution for and not in discharge of the indebtedness evidenced by the Original Contract.
  
2. **Miscellaneous.** The Mortgagor further agrees as follows:
  - A. All terms and conditions of the Mortgage not expressly deleted or amended by this Mortgage Amendment Agreement shall remain in full force and effect to the extent not expressly inconsistent herewith.
  - B. This Mortgage Amendment Agreement shall in all respects be governed by and construed in accordance with the substantive laws of the State of Indiana.
  - C. This Mortgage Amendment Agreement shall be binding upon the respective heirs, successors, administrators and assigns of the Mortgagor.
