This power of attorney is granted under and by authority of Subsection 5.1 (b) of Article V of the by-laws of GENERAL ACCIDENT INSURANCE COMPANY OF AMERICA which became effective February 20, 1992 and which provisions are in full force and effect, reading as follows:

5.1(b) The Board of Directors or Freeident, Vice Precident, or other officer designated by them or either of them shall have power to appoint Alternays-in-Fact and to authorize "them to execute on behalf of the Company bonds and undertakings, recognizances, contracts of indemnity and other writings obligatory in the reduce thereof, and to attach the seel of the Company thereto; and shell also have the power to remove any such Alternay-in-Fact at any time and revoke the power and suthority given to him.
