Grantor(s) hereby reserves a life estate in the above described premises.

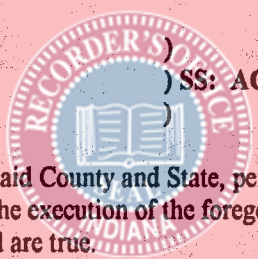
