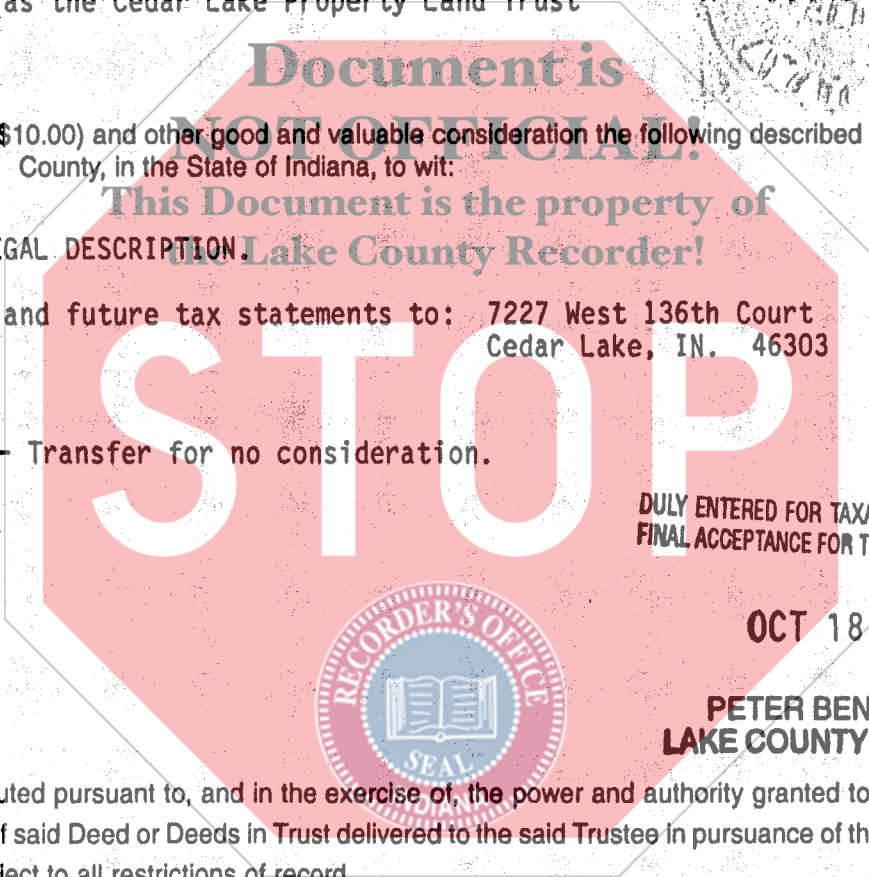

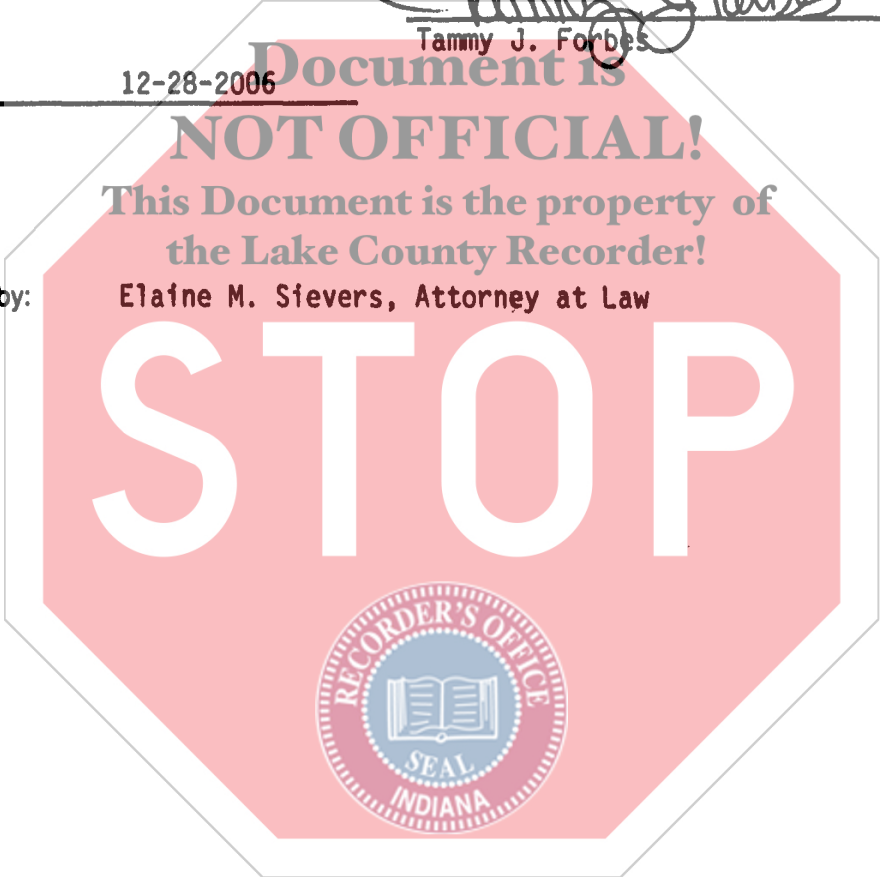


EXHIBIT A - LEGAL DESCRIPTION OF REAL ESTATE
