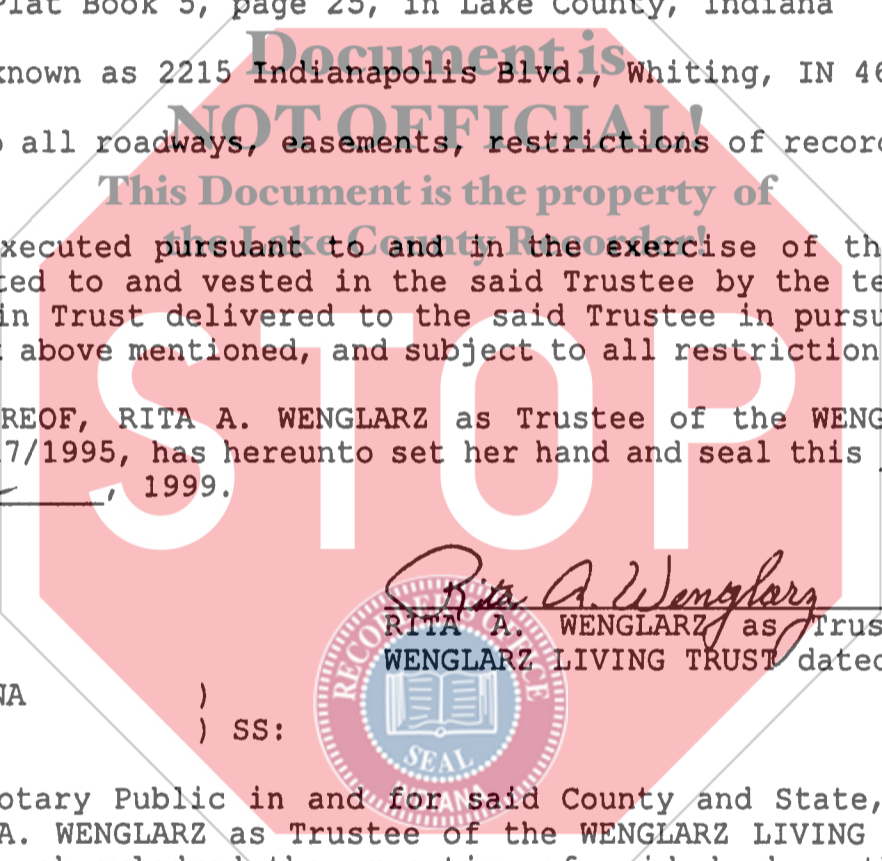
RITA A. WENGLARZ, of Lake County, Indiana,
