Parcel 1: A parcel of land in the Northeast Quarter of Section 31, Township 35 North, Range 9 West of the Second Principal Meridian, being more particularly described as follows: Commencing at the Northeast corner of said Section 31; thence South 69 degrees 05 minutes 22 seconds West, along the North line of said Section 31, a distance of 359.00 feet to the centerline of Pium Creek (also known as Hart Ditch); thence South 25 degrees 50 minutes 54 seconds West, along the centerline of Plum Creek, a distance of 2969,09 feet to a point on the South line of the Northeast Quarter of said Section 31, which point is also the Southeast come of Lot 21 in Twin Creck, Block 1, in the Town of Munster as shown in Plat Book 48, page 68, in the Office of the Recorder of Lake County, Indiana; thence South 88 degrees 51 minutes 59 seconds West, along the South line of said Lot 21 (also being the South line of the Northeast Quarter of said Section 31), a distance of 70.47 feet to a point of deflection in the Southerly line of sak! Lot 21, which point is the true point of beginning; thence North 64 degrees 09 minutes 06 seconds West, along the Southwesterly line of said Lot 21, a distance of 138.21 feet to the Southwest corner of said Lot 21; thence Southwesterly along the curved Southerly line of Twin Creek Boulevard and Redbud Road in said Twin Creek, Block 1, being a curve concave to the Northwest and having a radius of 50.0 feet (chord bearing South 45 degrees 38 minutes 32 seconds West, 53.49 feet), an arc distance of 56.44 feet; thence South 25 degrees 50 minutes 54 seconds West, 30.03 feet to a point on the South line of the Northeast Quarter of said Section 31; thence North 88 degrees 51 minutes 59 seconds East, along said South line, 176.40 feet to the point of beginning, all in the Town of Munster, Lake County, Indiana.

Parcel 2: A parcel of land in the Southeast Quarter of Section 31, Township 36 North, Range 9 West of the Second Principal Meridian and being more particularly described as follows: Commencing at the Northeast corner of said Section 31; thence South 89 degrees 05 minutes 22 seconds West; along the North line of said Section 31, a distance of 359.00 feet to the centerline of Plum Creek; thence South 26 degrees 50 minutes 54 seconds West, along the centerline of Plum Creek, a distance of 2959.09 feet to a point on the North line of the Southeast Quarter of said Section 31, which point is the true point of beginning; thence pointing South 25 degrees 50 minutes 54 seconds West, along the centerline of Plum Creek, a distance of 408.83 feet to a point on the Northeasterly right of way line of the Conrall Railroad (formerly P.C.C. & St. Louis Railroad); thence North 37 degrees 20 minutes 18 seconds West, along said Northeasterly right of way line a distance of 451.57 feet; thence North 88 degrees 51 minutes 59 seconds East along the North line of the Southeast Quarter of said Section 31; a distance of 452.24 feet to the point of beginning, all in the Town of Munster, Lake County, Indiana.
