THIS BOND MAY BE TERMINATED as to future acts of the Principal upon thirty (30) days written notice by the Surety; said notice to be sent to said Obligees at **LAKE COUNTY, INDIANA** by U. S. mail.

PROVIDED, However, that this bond may be continued at the option of the Surety by the issuance of a non-cumulative Continuation Certificate.

THIS BOND BECOMES EFFECTIVE on the **12TH** day of **OCTOBER, A.D., 1999**, for a period ending on the **31ST** day of **DECEMBER, A.D., 2000**.

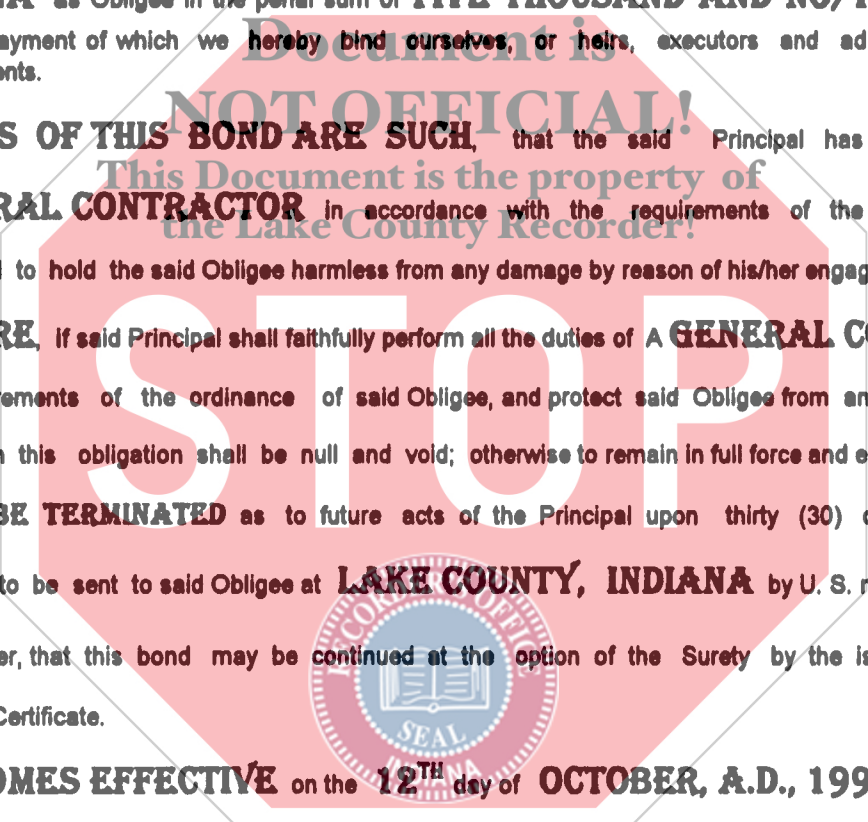

of Naperville, IL, their true and lawful Attorney(s)-in-Fact, with full power and authority hereby conferred to sign, execute and acknowledge, at any place within the United States, or, if the following line be filled in, within the area there designated the following instrument(s):
by his/her sole signature and act, any and all bonds, recognizances, contracts of indemnity, and other writings obligatory in the nature of a bond, recognizance, or conditional undertaking and any and all consents incident thereto

VOTED: That any bond, recognizance, contract of indemnity, or writing obligatory in the nature of a bond, recognizance, or conditional undertaking shall be valid and binding upon the Company when (a) signed by the President, any Vice Chairman, any Executive Vice President, any Senior Vice President or any Vice President, any Second Vice President, the Treasurer, any Assistant Treasurer, the Corporate Secretary or any Assistant Secretary and duly attested and sealed with the Company's seal by a Secretary or Assistant Secretary, or (b) duly executed (under seal, if required) by one or more Attorneys-in-Fact and Agents pursuant to the power prescribed in his or her certificate or their certificates of authority or by one or more Company officers pursuant to a written delegation of authority.

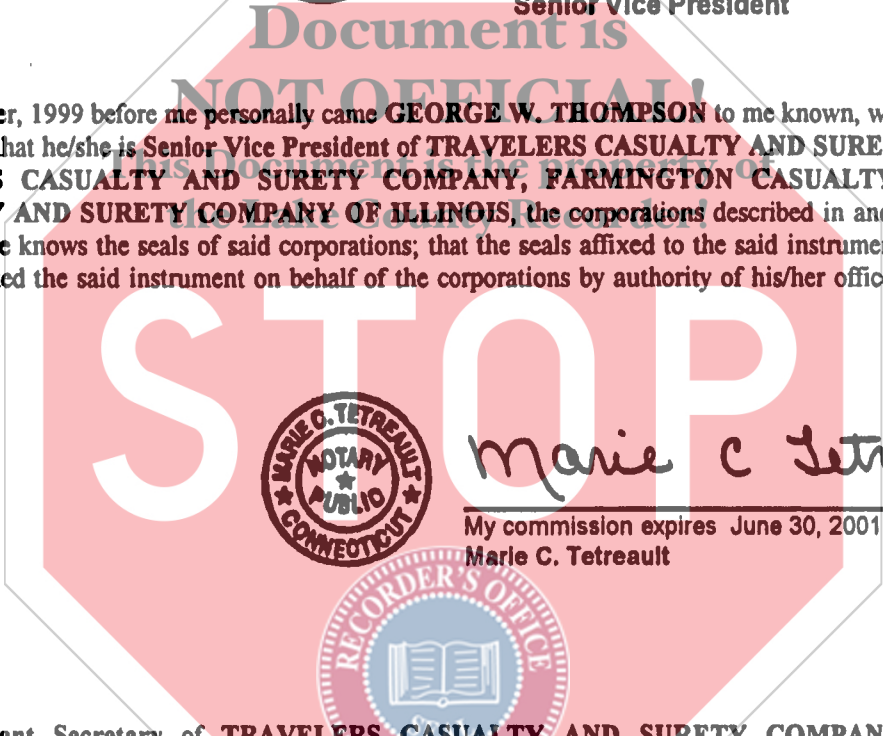

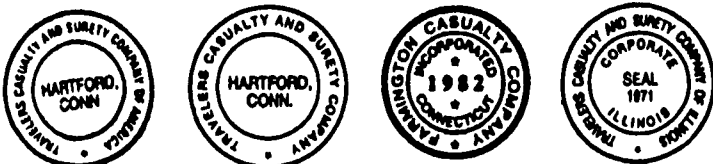



