**RELEASE OF MORTGAGE BY OWNER**

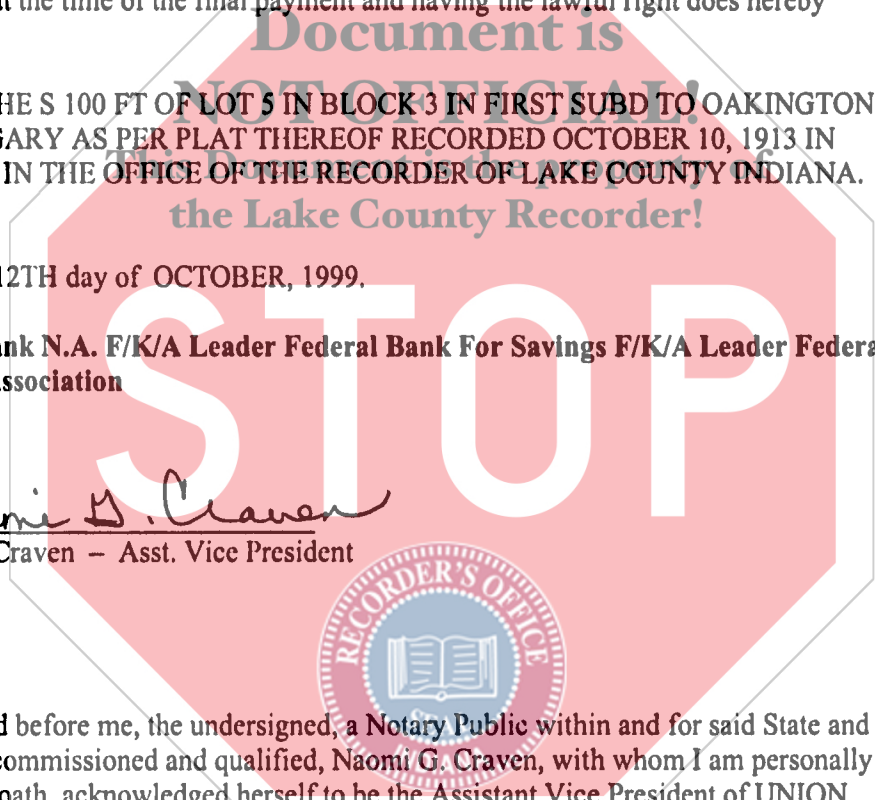

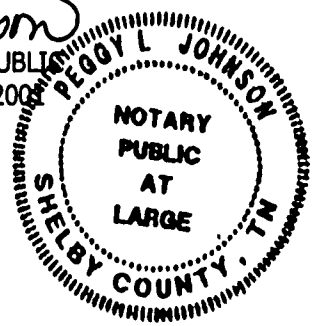
