Said tract contains 0.18 of an acre, more or less.

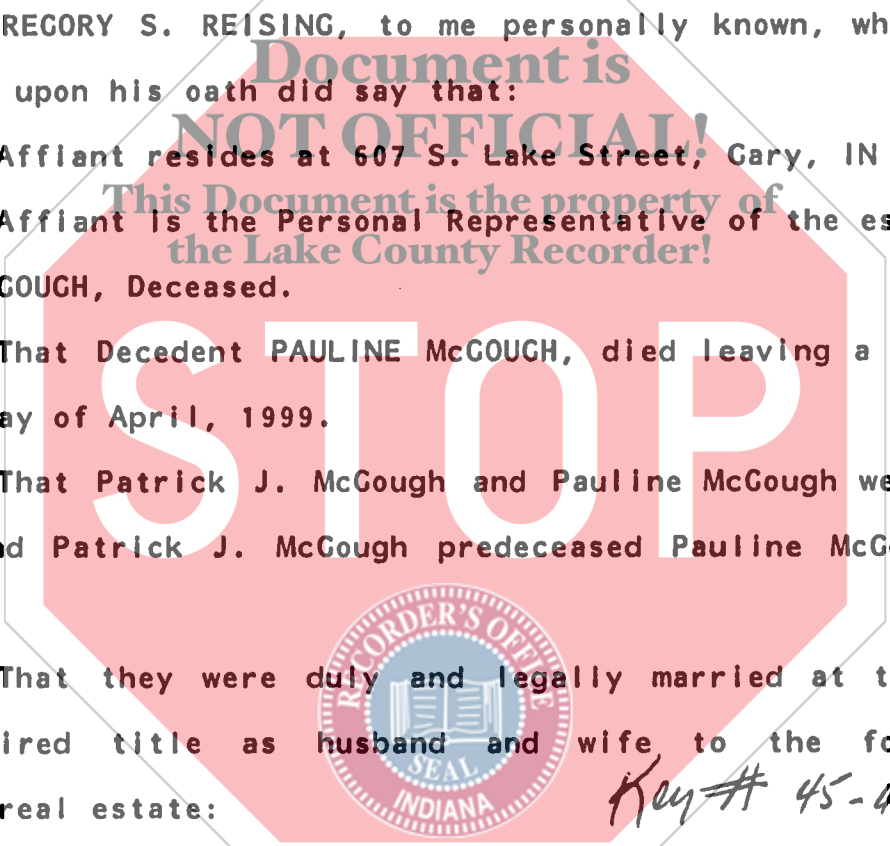
